ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 507.1006, *Florida Statutes*, the undersigned Florida for-profit corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. **Name of Corporation.** The present name of the corporation is "OCALA REGIONAL KIDNEY CENTER, INC." The name of the corporation is hereby changed to "OCALA KIDNEY ASSOCIATES, INC." Article I (Name of Corporation) of the Articles of Incorporation is amended to read as follows:

ARTICLE I

Name

The name of the corporation is amended to read as follows:

OCALA KIDNEY ASSOCIATES, INC.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
