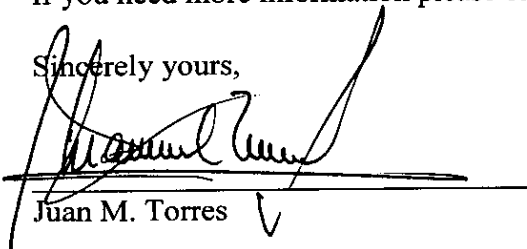

We would like to state that we received the 2000 renewal form and we filled out the form and the check was prepared. The form was mailed from the mailbox next to the office. The check was never paid by our bank so we suspect that the envelope was stolen. During this time the undersigned had his "identity stolen" and this created a lot of financial confusion. After this time we had illness in the family and the undersigned had to move out of the country. During this time, we moved from the original address(1400 NW 96<sup>th</sup> Avenue, Miami, Fl. 33172) and even though we left a forwarding address we never receive in our new address(10831 N.W. 29 Street, Miami, Fl. 33172) any correspondence from the Florida Department of State regarding a possible dissolution of our corporation.

Our business is small and charging us a reinstatement fee of \$1,050 would be a burden to us. Therefore we request that you abate the reinstatement fee and accept the above check to reinstate us in good standing. We formed the corporation on September 22, 1994 and have always paid promptly the annual fee. Now we know and can assure you that this incident will not happen in the future and will inquire if we don't receive an annual renewal form at the beginning of each year.
