

5. A majority of the shareholders and directors authorized that the corporation be dissolved.

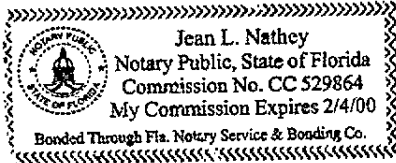




