## ARTICLES OF AMENDMENT

SECRETE IS PHILES The undersigned, being the President of Orchid Island Properties, Inc., a Florida Corporation (the "Corporation"), hereby certifies, pursuant to §607.1006 of the Florida Business Corporation Act, as follows:

- 1. The name of the corporation is Orchid Island Properties, Inc.
- 2. Article IV of the Articles of Incorporation is deleted in its entirety and replaced by the following:
