**ARTICLE I - NAME**

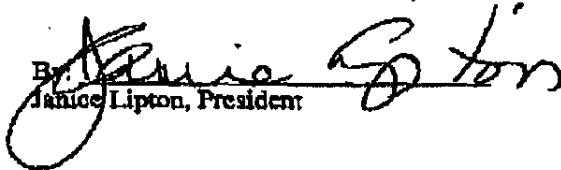
The name of the corporation is JBL Design, Inc. (the "Corporation").
