2909 W.A.K. CORPORATION, a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on December 27, 1994.

2. Pursuant to Section 607.1006, Florida Statutes, this amendment to the Articles of Incorporation was adopted by the members of the Corporation as of August 5, 2021, 2021 and the number of votes cast for the amendment was sufficient for approval.
