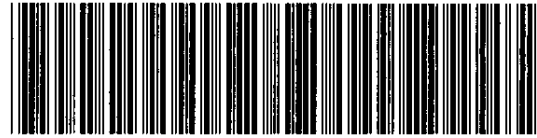

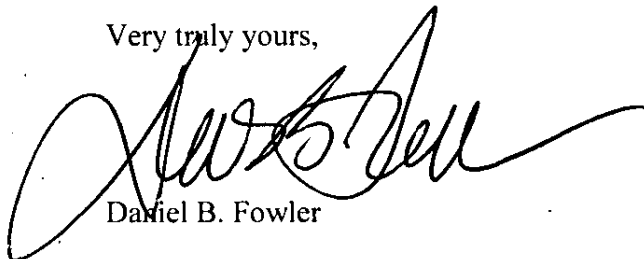

AMENDMENTS ADOPTED:

The following amendments to the Articles of Incorporation were adopted by the corporation:

1. Article I is hereby amended by altering its entirety so as to read:

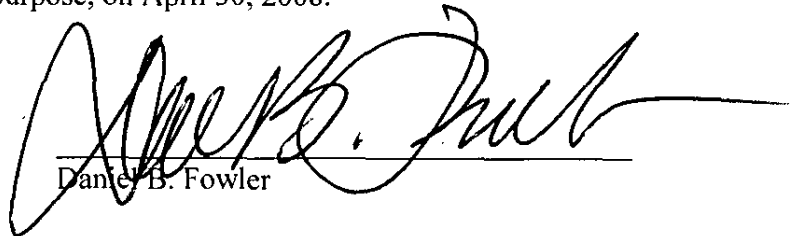
"The name of this corporation shall be DAN & SYLVIE FOWLER, INC."

5. Article XIII is deleted in its entirety.

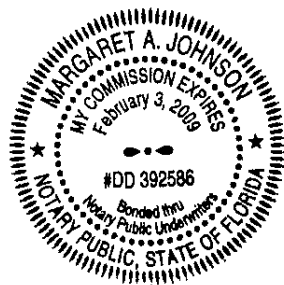
6. The date of the adoption of the above Amendments is April 30, 2008.

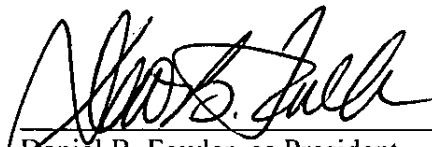

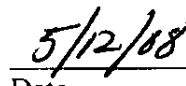
