I am writing to request a reduction in penalties for the following reasons. In 1999 American General Water Systems, Inc. had a fire which destroyed our entire office. We lost our building and contents valued at approximately \$250,000. American General Water Systems then had a financial hardship due to being under insured by \$200,000. This forced us to move into a temporary structure at a new address. Also, we were forced to release a good number of our office staff and employees. Furthermore, I had a heart attack during this period of time. The total turmoil, my health, loss of employees, and the new address caused us to inadvertently not file our corporate return. In addition, our registered agent moved and was never notified of the administrative dissolution. I can provide the necessary documentation to qualify the above statements. Please take into consideration the above items.
