The undersigned Incorporator of these Articles of Incorporation is a natural person competent to contract and a Certified Public Accountant duly licensed to render services as such under the laws of the State of Florida, and hereby forms a corporation for profit under the Professional Service Corporation Act and other laws of the State of Florida.

Article I. Name

The name of this corporation is Martin & Associates, C.P.A.'s, P.A., and its principal office is located at, 8130 Baymeadows Circle W. #307, Jacksonville, FL 32256.

Article II. Duration

This corporation is to exist perpetually commencing on the date of execution of these articles.

Article III. Purpose

This corporation is organized to engage in every phase and aspect of the business of accounting which is permitted under the laws of the State of Florida and rendered only through individuals authorized by the laws of the State of Florida to render such professional services.

Article IV. Corporate Powers

This corporation shall have all and singular the following powers:

- E To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objects of this corporation enumerated in these Articles of Incorporation, or any amendment of it, necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
- F. To have, in furtherance of the corporate purpose, all of the powers conferred upon corporations organized under the Florida General Corporation Act subject to any limitations contained in the Florida Professional Service Corporaion Act and in these articles of incorporation.

Article V. Capital Stock

This corporation is authorized to issue one thousand shares of ten (\$10.00) par value common stock.

Article VI. Initial Registered Office and Agent
