ARTICLE I - NAME

The name of the corporation is INTERNATIONAL CENTER FOR COMMUNICATIONS, INC., located at 10920 S.W. 161 Place, Miami, Florida 33196.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
