**ARTICLES OF INCORPORATION  
OF  
DESTIN COMMUNITY HOSPITAL, INC.**

The undersigned, acting as Incorporator for the purpose of forming a Corporation under the provisions of the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE  
NAME**

The name of the corporation is Destin Community Hospital, Inc. (hereinafter, the Corporation").

**ARTICLE TWO  
PRINCIPAL OFFICE**

The principal office and mailing address of the Corporation is 111 Second Avenue, N.E., Suite 1201, St. Petersburg, Florida 33701.

**ARTICLE THREE  
DURATION**

The duration of the corporation is perpetual.

**ARTICLE FOUR  
PURPOSE**

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

**ARTICLE FIVE  
CAPITALIZATION**

The aggregate number of shares of all classes of stock which the Corporation is authorized to issue is 10,000 shares of Common Stock, par value \$1.00 per share.

**ARTICLE SIX  
REGISTERED OFFICE AND AGENT**

The address of the Corporation's initial registered office is 111 Second Avenue N.E., Suite 1201, St. Petersburg, Florida 33701, and the name of its initial registered agent at such office is Ruth Minzer Davidson.

**ARTICLE SEVEN  
DIRECTORS**

Section 1. The business of the Corporation shall be managed by a board of directors. The number of directors on the Board of Directors shall be set forth in the by-laws of the Corporation, as hereafter adopted and amended by the shareholders of the Corporation. The number of directors constituting the Corporation's initial Board of Directors shall be one.

Section 2. The name and address of sole initial director of the Corporation is: Scott L. Hopes, 111 Second Avenue, N.E., Suite 1201, St. Petersburg, Florida 33701.

**ARTICLE EIGHT  
INCORPORATOR**

The name and address of the incorporator of the Corporation is: Ruth Minzer Davidson, 111 Second Avenue, N.E. Suite 1201, St. Petersburg, Florida 33701.

**ARTICLE NINE  
INDEMNIFICATION**

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
