Pursuant to Section 607.1403 of the Florida Statutes, the undersigned corporation adopts these Articles of Dissolution.

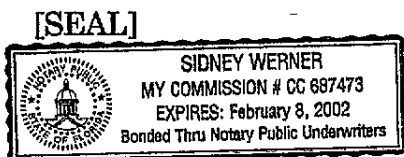
- FIRST: The name of the corporation is DESTIN COMMUNITY HOSPITAL, INC.

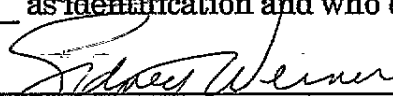
