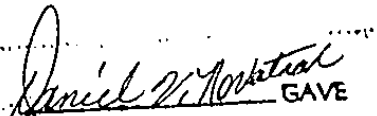

ARTICLES OF INCORPORATION
OF

The undersigned Incorporator makes, subscribes, acknowledges, and files with the Corporate Department of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit of the state of Florida.

ARTICLE I

Name

The name of this corporation is THINK INK & DESIGN COMPANY.

ARTICLE II

Term of Existence

This corporation shall commence as of the date of the filing of these Articles of Incorporation with the Secretary of State and shall have perpetual existence.

ARTICLE III

Nature of Business

This corporation may engage in an activity or business permitted under the laws of the United States and of this State.

ARTICLE IV

Capital Structure

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock, having a par value of \$1.00 per share. Each of the said shares of stock shall entitle the holder to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property or in labor and services at a fair valuation to be fixed by the Board of Directors at a meeting called for such purposes. All stock, when issued, shall be paid for and be non-assessable.

ARTICLE V

Initial Registered Agent and Registered Office

The initial agent of this corporation shall be Daniel V. Novatnak. The street address of the initial registered office of this corporation, which is identical with the business office of the

ARTICLE VI
Board of Directors

There shall be a Board of Directors for this corporation which shall consist of not less than one (1). Except for the number constituting the Initial Board of Directors, the number shall be decided by resolution of the shareholders.

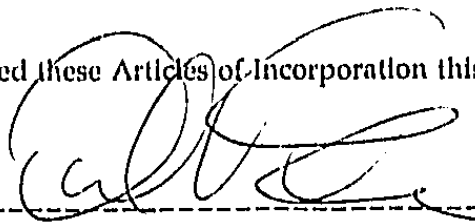

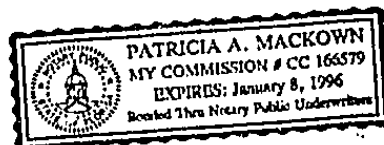

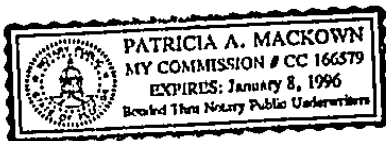
