authority to issue is five hundred (500) of no par value.

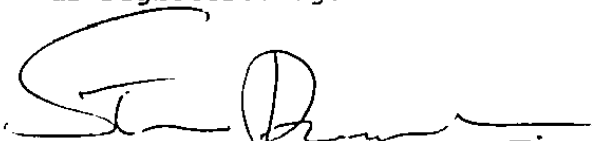
ARTICLE FIVE
