ARTICLE I - NAME AND ADDRESS

The name of this Corporation is C & J ENTERPRISES, INC., whose address is 3830 Indian Trail, Destin, Florida 32541.

ARTICLE II - DURATION

This Corporation shall exist perpetually.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of real estate development and for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

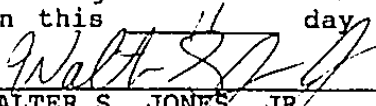

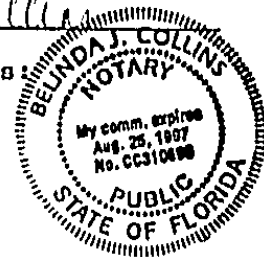
