Article I - Name

The name of this corporation is Champion Building and Design, Inc. The mailing address for the corporation is 15417 S.W. 42nd Avenue, Archer, Florida 32618.

Article II - Duration

This corporation shall have a perpetual existence, commencing on the date of filing these articles with the Department of State.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

This corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

Article V - Preemptive Rights


Article IX - Indemnification


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

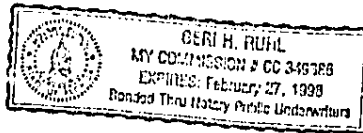
