I, the under signed, all being of full age, do hereby agree to become a corporation for profit under the laws of the State of Florida, of the United States of America, by and under the provisions and statutes of that state, providing for the formation, liability, rights, privileges, benefits and obligations conferred and imposed by said law on corporations organized pursuant to the provisions thereof, and hereby make, subscribe and acknowledge and file these Articles of Incorporation as follows:

Article I

Term of Existence

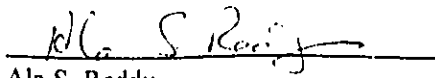
This corporation shall exist perpetually unless dissolved according to law. Corporate existence commences at the moment of executing the corporate charter.
