ARTICLES OF INCORPORATION
FOR
COMMERCIAL LANDSCAPING,
INC.

THE UNDERSIGNED DOES HERE BY SUBSCRIBE TO, ACKNOWLEDGE AND FILE
THE FOLLOWING ARTICLES OF INCORPORATION FOR THE PURPOSE OF CREATING
A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I: NAME

THE NAME OF THE CORPORATION IS COMMERCIAL LANDSCAPING, INC.

ARTICLE II: DURATION

THE CORPORATION SHALL EXIST PERPETUALLY, COMMENCING ON THE DATE OF
THE FILING OF THESE ARTICLES, UNLESS SOONER DISSOLVED ACCORDING TO
LAW.

ARTICLE III: PURPOSE

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF TRANSACTING ANY
AND ALL ACTIVITIES OR BUSINESS PERMITTED UNDER THE LAWS OF THE
UNITED STATES AND FLORIDA.

ARTICLE IV: CAPITAL STOCK

THIS CORPORATION IS AUTHORIZED TO ISSUE ONE THOUSAND (1000) SHARES OF
COMMON STOCK AT ONE (1.00) DOLLAR PAR VALUE. THE CAPITAL STOCK SHALL
BE PAID IN CASH OR IN PROPERTY, AT JUST VALUATION TO BE FIXED BY THE
INCORPORATOR, OR BY THE DIRECTORS AT A MEETING CALLED FOR SUCH
PURPOSE, OR AT THE ORGANIZATIONAL MEETING.

ARTICLE VIII: INCORPORATOR

ARTICLE IX: INDEMNIFICATION

THE CORPORATION SHALL INDEMNIFY ANY OFFICER OR DIRECTOR OR ANY FORMER OFFICER OR DIRECTOR, TO THE FULLEST EXTENT PERMITTED BY LAW EITHER NOW EXISTING OR HEREAFTER ENACTED.

ARTICLE X:

NO CONTRACT OR OTHER TRANSACTION BETWEEN THIS CORPORATION AND ANY OTHER CORPORATION, AND NO ACT OF THIS CORPORATION SHALL IN ANY WAY BE AFFECTED OR INVALIDATED BY THE FACT THAT ANY OF THE DIRECTORS OF THIS CORPORATION ARE PECUNIARILY OR OTHERWISE INTERESTED IN, OR ARE DIRECTORS, OR OFFICERS OF SUCH OTHER CORPORATION. ANY DIRECTOR INDIVIDUALLY, OR ANY FIRM OF WHICH ANY DIRECTOR MAY BE A MEMBER, MAY BE A PART TO, OR MAY BE PECUNIARILY OR OTHERWISE INTERESTED IN, ANY CONTRACT OR TRANSACTION OF THIS CORPORATION, PROVIDED THAT THE FACT THAT HE OR SUCH FIRM SO INTERESTED SHALL BE DISCLOSED OR SHALL HAVE BEEN KNOWN TO THE BOARD OF DIRECTORS OF A MAJORITY THEREOF, AND ANY DIRECTOR OF THIS CORPORATION WHO IS ALSO A DIRECTOR OR AN OFFICER OF SUCH CORPORATION, OR WHO IS SO INTERESTED MAY BE COUNTED IN DETERMINING THE EXISTENCE OF A QUORUM AT ANY MEETING OF THE BOARD OF DIRECTORS OF THIS CORPORATION WHICH SHALL AUTHORIZE ANY SUCH CONTRACT OR TRANSACTION WITH LIKE FORCE AND EFFECT AS IF HE OR SHE WERE NOT SUCH DIRECTOR OR OFFICER OF SUCH OTHER CORPORATION, OR NOT SO INTERESTED.

ARTICLE XI :

THE PRIVATE PROPERTY OF THE STOCKHOLDERS SHALL NOT BE SUBJECT TO THE PAYMENT OF THE CORPORATE DEBTS TO ANY EXTENT WHATEVER. THE CORPORATION SHALL HAVE A FIRST LIEN ON THE SHARES OF ITS STOCKHOLDERS AND UPON ANY DIVIDENDS DUE THEM FOR ANY INDEBTEDNESS OF SUCH STOCKHOLDERS TO THE CORPORATION.

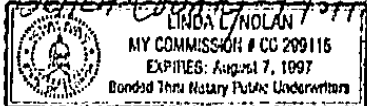
ARTICLE XII: AMENDMENT
