The undersigned subscribers to these. Articles of Incorporation, persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is Yovaish Building Services, Inc.

ARTICLE II - NATURE OF BUSINESS

The general character, purpose, and nature of business to be transacted by this corporation is as follows:

- (a) To acquire by purchase, lease or otherwise, lands and interest in lands, owned, held or occupied by the corporation, building or other structures, nor or hereafter erected on any lands owned, held or occupied, and to encumber or dispose of any lands, or interest in lands, and any buildings or other structures, at any time owned or held by the corporations. To buy, sell mortgage, exchange, lease, hold for investment or otherwise, use and operate, real estate of all kinds, improved, or any right or interest therein.
- (b) To acquire, by purchasee, lease, manufacture or otherwise, any personal property deemed necessary or useful, in the equipment, furnishings, improvement, development or management of any property, real or personal, at any time owned, held or occupied by the corporation, and to invest, trade, lease rent, encumber or dispose of any personal property at any time owned or held by this corporation.
- (c) TO carry on in any capacity any business or trade deemed legal in the State of Florida.
- (d) To contract debts and borrow money, Isaac and sell or pledge bonds, debentures, note and other evidences of indebtedness, and to execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as required.

- (h) To enter into, make, perform and carry out contracts and agreements of every kind, for any lawful purpose, without limit as to amount, with any firm, association or exporation; and to transact any farther and other business necessarily connected with the purposes of this corporation, or calculated to facilitate the same
- (1) To carry on any or all of its operations and business, and to promote Its objects within the State of Florida or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all of the general powers of like corporations.
- (j) To do any or all of the things herein set forth to the same extent or natural persons right or could do; and in any part of the world as principals, agents, contractors or otherwise, alone or in company with others, and to do and perform all such things and acts as may be necessary, profitable or expedient in carrying on any of the business or acts above named.
