**ARTICLES OF INCORPORATION
OF**

MERRELL WELDING, INC.

The undersigned subscriber to those Articles of incorporation, a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be and is "Merrell Welding, Inc."

ARTICLE II. NATURE OF BUSINESS

The purpose of this corporation is to transact any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statute.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock with a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be One Dollar (\$1.00) in money, property or services or such greater amount as the Board of Directors may from time to time fix and determine.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation will begin is Eight Thousand Dollars (\$8,000.00).
