I, the undersigned incorporator, hereby make, acknowledge and file these Articles of Incorporation for the purpose of forming a corporation pursuant to Section 621 of the Florida Corporation Act.

ARTICLE I

NAME

The name of this Corporation shall be:

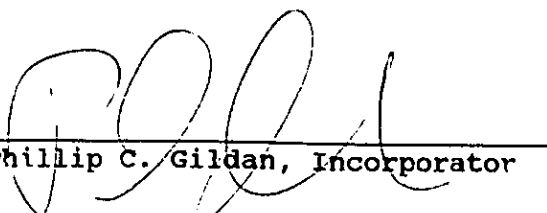

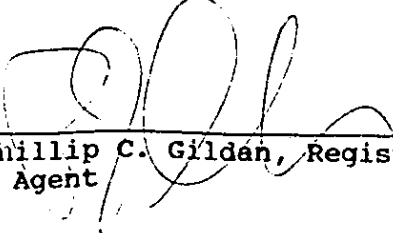
