**ARTICLE I. NAME**

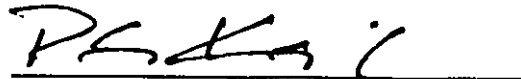
**ARTICLE IX. INDEMNIFICATION**

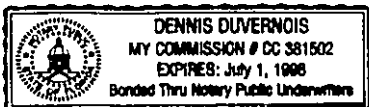
