ARTICLES OF INCORPORATION

OF

1305 COLLEE, INC.

The undersigned incorporator, for the purposes of forming a corporation under the laws of the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME




