**ARTICLES OF AMENDMENT
OF
DARYL B. CRAMER, P.A.**

The provisions of the Articles of Incorporation of **DARYL B. CRAMER, P.A.**, a Florida corporation (the "Corporation"), filed with the Department of State, State of Florida, on March 6, 1995, are hereby amended as follows:

Article I shall be deleted and the following inserted in lieu thereof:

ARTICLE I

Name of Corporation
