

ARTICLES OF INCORPORATION

OF

ARCADIAN LANDSCAPING, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be Arcadian Landscaping Inc.

ARTICLE II

The principle place of business and mailing address of this corporation shall be 5300 S.W. 166 Avenue, Ft. Lauderdale, Fl 33331-1383.

ARTICLE III

The number of shares of stock that this corporation is authorized to have outstanding at any one time is five hundred shares at \$1.00 par value.

ARTICLE IV

Pursuant to 607.034, Florida Statutes, the registered office of this corporation in the state of Florida shall be 516 W. Oakland Park Blvd., Fort Lauderdale, Fl 33311, and the Registered agent in the state of Florida shall be Brian K. Boggs.

ARTICLE V

This corporation is to exist perpetually.

ARTICLE VI

This corporation shall have two directors initially. The number of directors may be increased or diminished from time to time by the by-laws adopted by the stockholders.

In accordance with Florida Statute 607.77, it is expressly provided herein that the shareholders of this corporation shall have preemptive rights in any new stock of the same kind, class or series as that they already hold and they shall have the right to purchase their pro rata share therof (as nearly as may be done without issuance of fractional shares) at the price at which is offered to others, which price, in the case of par value shares, may be in exess of par.

ARTICLE IX

These Articles of Incorporation may be amended in the manner provided by law.

Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at the stockholders meeting by the unanimous vote of the stockholders entitled to vote thereon.

ARTICLE X

Pursuant to F. c. Stat. 607.097(4), at all elections of directors of this corporation, each shareholder shall be entitled to as many votes as shall equal the number of votes which (except for these provisions as to cumulative voting) he would be entitled to cast for the election of directors with respect to his shares multiplied by the number of directors to be elected, and he may cast all such votes for a single director, or may distribute them among the number to be voted for, or any two or more of them, as he may see fit.
