ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of HALF PRICE FURNITURE WAREHOUSE, INC. under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE I - NAME

The name of the corporation is: HALF PRICE FURNITURE WAREHOUSE, INC.

ARTICLE III - COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing these articles of incorporation.

ARTICLE IV - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated in accordance with applicable Florida statutes. The purpose of this corporation is to render in and all services pertaining to HALF PRICE FURNITURE WAREHOUSE, INC.

ARTICLE V - AUTHORIZED SHARES
