# ARTICLES OF INCORPORATION OF JOANNE C. HOLT, P.A., C.P.A.

The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional corporation ("corporation"), pursuant to Chapter 621, Florida Statutes.

### ARTICLE
