The undersigned, acting as the incorporator of a professional corporation under the Florida Business Corporation Act and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I. NAME OF CORPORATION**

The name of the corporation is KISNAD, P.A.

**ARTICLE II. COMMENCEMENT AND DURATION OF  
CORPORATE EXISTENCE**

Corporate existence shall commence on the date the Articles are filed by the Department of State and shall exist perpetually thereafter until dissolved according to law.

**ARTICLE III. CORPORATE PURPOSE**

This corporation is organized for the purpose of engaging in the practice of medicine within the State of Florida and to take all actions that are necessary or proper in connection with that practice.

**ARTICLE IV. CAPITAL STOCK**

The power to adopt, alter, amend or repeal by-laws shall be vested in the board of directors and the shareholders, but the board of directors may not alter, amend or repeal any by-laws adopted by the shareholders if the shareholders provide that the by-laws shall not be altered, amended or repealed by the board of directors.
