**ARTICLES OF INCORPORATION
OF
LAMDA GROUP INC.**

The undersigned Incorporator, natural person competent to contract, hereby form a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE II - TERM AND COMMENCEMENT OF EXISTENCE

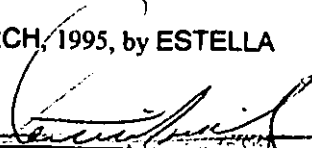
