ARTICLE I - NAME
THE NAME OF THE CORPORATION IS:

SAWTOOTH DESIGNS, INC.

ARTICLE II - DURATION

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE COMMENCING ON THE DATE OF THE FILING OF THESE ARTICLES WITH THE DEPARTMENT OF STATE.

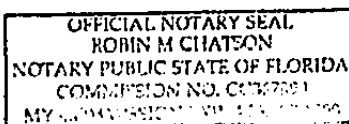
