The undersigned incorporator to these Articles of Incorporation, natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

Creative Contracting, Inc. shall be the name of this corporation.

ARTICLE II - NATURE OF BUSINESS

The general character or nature of the business to be transacted by this corporation is: The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
