Articles of Incorporation of: American Auto/Marine Wiring, Inc.

I, the undersigned, hereby associate myself together for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do certify to the following Articles of Incorporation.

ARTICLE I

The general nature of the business to be transacted and carried on by this corporation and its object and purpose is to transact any and all lawful business regardless of its nature or description.

ARTICLE II

The maximum number of shares which this corporation shall be authorized to issue and have outstanding at one time shall be limited to one thousand (1000) shares of common stock; five dollar (\$5.00) par value.

The consideration for the issuance of such shares of stock, or any part thereof, shall be money current of the United States of America, or property or services of value at least equivalent to the value of the stock to be issued, the same to be fixed and determined by the Board of Directors of this corporation at any

mooting of the Board. Whenever any share or shares of stock are issued in consideration of payment to be made in property or in services, the fair and just value of the property to be transforred or the services to be performed or rendered as a consideration for the issuance of said stock, shall be fixed by the Board of Directors of this corporation at any regular meeting of the Board or at any special meeting for which the fixing of that value is one of the purposes for which the meeting is called. The judgment and decision of the Board of Directors pertaining thereto shall be conclusive and binding upon all persons whatsoever in dealing with the corporation and the shareholders thereto. Any and all shares of stock of this corporation shall be issued for the consideration, or for not less than the consideration, fixed and determined as aforesaid, whether such consideration be cash, property or services, and any and all shares of this corporation's stock so issued shall be deemed fully paid and non-assessable.

ARTICLE III

The corporation shall begin business with paid in capital of not less than five hundred dollars (\$500.00).

ARTICLE IV

The corporation shall have perpetual existence.

ARTICLE V

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that
