**ARTICLES OF INCORPORATION
OF
REFLECTIONS BUILDING SERVICES, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation is: "Reflections Building Services, Inc."

ARTICLE II

The address of the principal office of the corporation shall be 465 SW Whitmore Dr., Port St. Lucie, Florida, 34984.

ARTICLE III

The corporation shall have the authority to issue not more than 500,000 shares of Class A common stock with a par value of \$.01 per share that has unlimited voting rights and 500,000 shares of Class B common stock with a par value of \$.01 per share that has no right to vote. Both the Class A common stock and the Class B common stock together and without preference are entitled to receive the net assets of the corporation upon dissolution of the corporation.

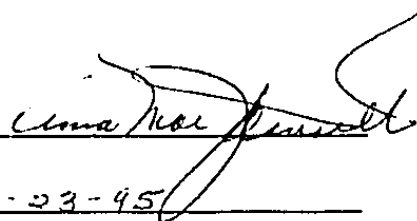
