ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is NETWORK SOFTWARE, INC.

ARTICLE II - DURATION

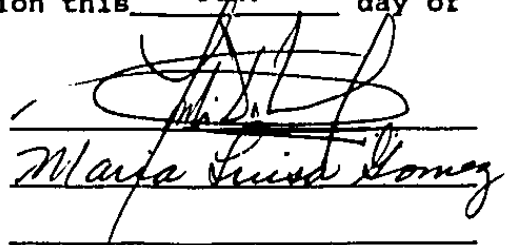
