I am writing with regards to the erroneous dissolution and revocation of Evergreen Forest Corporation at

140 West Monroe Street, Jacksonville, FL 32202-3706.

The above Corporation was effectively dissolved on Sept 26, 1997 without having received prior notice. However,

the Florida Dept of State has, after further correspondence, allowed for the waiving of a \$585

dollar reinstatement fee. The Corporation has been informed that a lesser fee of \$165 dollars will be
