NAME. The name of the corporation shall be:



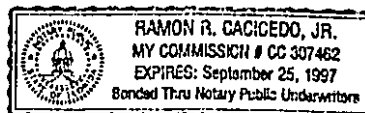
