ARTICLE I - Name and Address

The name of this corporation is 1 NATION TECHNOLOGY CORP. The address of the corporation's principal office is: 19602 LAKE OSCEOLA LANE, ODESSA, FL 33536.

ARTICLE II - Duration

This corporation shall have perpetual existence.

ARTICLE III - Purpose

This corporation is organized to include the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes (1993), as presently enacted and as it may be amended from time to time.

ARTICLE IV - Capital Stock

ARTICLE IX - Amendment

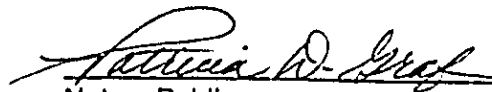

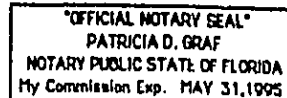

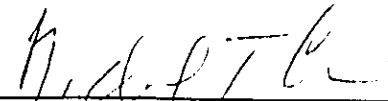
