**ARTICLES OF INCORPORATION  
OF  
MOTZ MARKETING CONCEPTS, INC.**

Linda A. Motzenbecker, the undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, forms a corporation for profit under the laws of the State of Florida.

**ARTICLE I**

The name of the corporation is Motz Marketing Concepts, Inc.

**ARTICLE II**

The corporation is authorized to and may engage in any activity or business which is lawful in the State of Florida.

**ARTICLE III**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one thousand (1,000) shares of common capital stock, each share having a par value of \$1.00 (one dollar). Authorized common capital stock may be paid for in cash, services or property at a just value to be fixed by the Directors of the corporation at any regular or special meeting thereof.

**ARTICLE IV**

The amount of capital with which the corporation shall commence business is \$500.00.

**ARTICLE V**

This corporation shall have a perpetual existence.

**ARTICLE VI**

The initial street address of the principal office of the corporation is to be 3328 San Domingo Street, Clearwater, Florida, 34619. The Directors may from time to time designate such other address and place for the principal office of the corporation as they deem appropriate.

#### **ARTICLE VII**

The initial number of directors of this corporation shall be one (1). This number may be increased from time to time pursuant to the bylaws adopted by the stockholders of the corporation, but shall never be less than one.

#### **ARTICLE VIII**

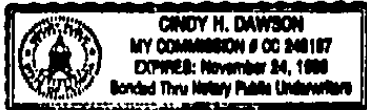
