**ARTICLE I. CORPORATE NAME.**

The name of this corporation is: The Insulator of South Florida.  
The address of the principal office of this corporation is:

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III. CAPITAL STOCK.**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000.

**ARTICLE IV. TERM OF EXISTENCE.**

This Corporation shall have perpetual existence commencing upon filing of these articles.




ARTICLE IX. AMENDMENT.
