ARTICLES OF INCORPORATION
for

The undersigned, a natural person, competent to contract, and a licensed medical doctor, acting as incorporator of a corporation under the provisions of Chapters 607 and 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation is JEFFRY B. POTASH, M.D., P.A..

Article II

The principal office and mailing address of this corporation is 8811 S.W. 8 Street, Plantation, Florida 33324.

Article III

The duration of this corporation is to be perpetual.

Article IV

The nature of the business and the objects and purposes to be transacted, promoted, or carried on by the corporation are in any aspect and phase of the practice of medicine and in any activities which shall facilitate and promote the practice of medicine.

Article V

The corporation shall have authority to issue 100 shares, all of one class, no par value.

Article VI

Article VII

The number of directors constituting the Board of Directors shall be fixed as provided by the bylaws, but shall not be less than one.

The name and address of the incorporator is Jeffry B. Potash, 8811 S.W. 8 Street, Plantation, Floorida 33324.


Article X

Article XI


These Articles of Incorporation may be amended in any manner authorized by law at the time of amendment.
