The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be CANADIAN POLARIS INVESTMENTS INC.

ARTICLE II

The principal office and mailing address of the Corporation is 101 Hawksbill Way, Jupiter, Florida 33458.

ARTICLE III

The purpose of the Corporation is to engage in making investments, and to further engage in any activity or business permitted under the laws of the United States of America or the State of Florida.
