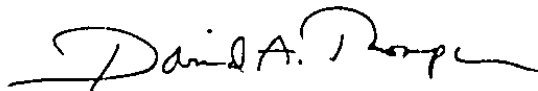

ARTICLES OF INCORPORATION

OF

TURF TROOPERS, INC.

The undersigned Incorporator, for purposes of organizing a corporation under the Florida Business Corporation Act, states as follows:

ARTICLE I

NAME

The name of the corporation is TURF TROOPERS, INC., whose business address shall be 6816 - 88th Avenue North, Pinellas Park, FL 34666.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing as of the date of filing of these Articles of Incorporation.

ARTICLE III

PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of \$1.00 par value common stock.

#### ARTICLE V
