The undersigned, hereby make, subscribe, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I**  
**NAME OF CORPORATION**

The name of the corporation shall be CINEPLUS, INC. The address of the corporation is 392 21st Street, Vero Beach, Florida 32960.

**ARTICLE II**  
**PURPOSE OF BUSINESS**

The corporation is organized for the purpose of engaging in any activity permitted under the laws of the United States or of this State.

**ARTICLE III**  
**CAPITAL STOCK**

The capital stock of this corporation shall consist of 4,000 shares of \$1.00 par value common stock, fully paid and non-assessable. The whole or part of the capital stock of this corporation may be paid for in lawful money of the United States of America or in property, labor or services as a just valuation to be fixed by the Directors.
