

**ARTICLES OF INCORPORATION
OF
INTERNATIONAL REALTY CONSULTANTS, INC.**

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is **INTERNATIONAL REALTY CONSULTANTS, INC.** The principal place of business of the corporation is 3401 Tamiami Trail North, Suite 207, Naples, Florida 33940. The mailing address of the corporation is 3401 Tamiami Trail North, Suite 207, Naples, Florida 33940.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - Stated Capital - Classes of Stock

The corporation is authorized to issue 1000 shares of common stock at \$1.00 par value.

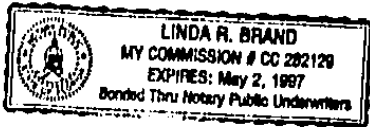
