The undersigned subscribers as to these Articles of Incorporation, natural persons competent to contract, hereby suscribe to and form a corporation for profit under the laws of the State of Florida.

ARTICLE I--NAME

The name of the corporation is CLASSIC CARPET CLEANERS OF BAY COUNTY, INCORPORATED.

ARTICLE II--NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of this state.

ARTICLE III--CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one thousand (1,000) shares of common stock, each share having the par value of five dollars (\$5.00).

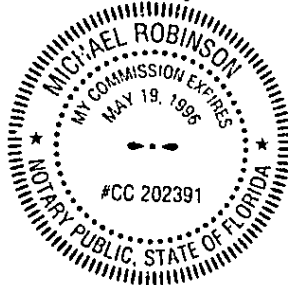
