I, HECTOR NUNEZ, the undersigned, a PUBLIC INTERPRETER OF THE
REPUBLIC OF VENEZUELA, hereby advise you as follows:

1. The Venezuelan Law does not allow a Notary Public to acknowledge documents and/or signatures in a language other than Spanish.
2. This is the reason why the enclosed document, prepared in English, was first translated into Spanish by a Public Interpreter and then a Notary Public acknowledged the Spanish version.
3. In addition, Notary Publics are not subject to a commission with an expiration date. Their position is permanent and they can only be removed by the Ministry of Justice.
4. Instead, the Title of Public Interpreter, also granted by the Ministry of Justice, is for life.

The undersigned, acting as incorporator of a corporation, hereby adopts the following Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is Instruser Co. and the principal office address is

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares of common stock, each share having the par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the Board of Directors from time to time.
