ARTICLES OF INCORPORATION

OF

ARNOLD HAUSNER, INC.

The undersigned, for the purpose of forming a corporation under the Florida Professional Corporation Act, Florida Statutes §621.01, et seq., hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of this corporation is ARNOLD HAUSNER, INC.

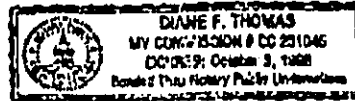
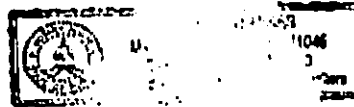
