ARTICLES OF INCORPORATION
OF
SARA ROGERS, INC.

ARTICLE I - NAME

The name of this corporation is Sara Rogers, Inc. The principal address of this corporation is 1540 N.E. 191 Street, Apt. #202, North Miami Beach, Florida 33179.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

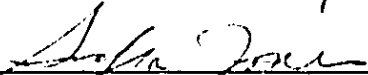
ARTICLE IX - INDEMNIFICATION

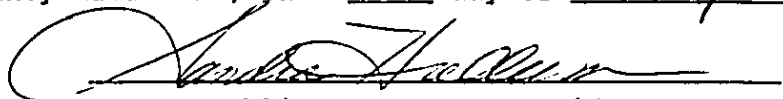

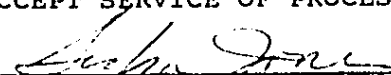

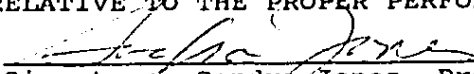
