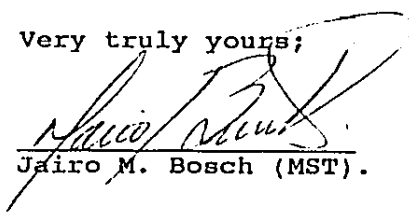

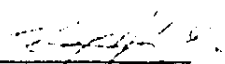

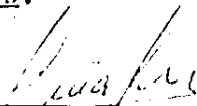
ARTICLE X. Liquidation
