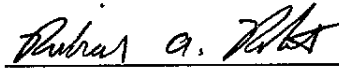
**ARTICLE I**

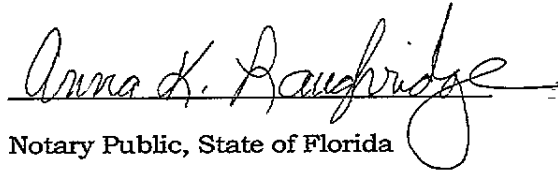
